#### 9) NEW BUSINESS -

A) Insurance for OCTV Drone - Service

Station Manager Service informed board of multiple insurance quotes for drone coverage ranging from \$730, \$800 to \$875 (from existing OCTV insurance company Gandolfi). Liability of \$1,000,000, suggested by all three insurance quotes. Current insurance company requires a separate rider.

B) Presentation on Station Location - Village of Oxford

Interim Manager James Vettraino presented Village interest, based on council resolution, in working with OACCC/OCTV on a relocation partnership for the village owned space. Village is seeking to understand level of interest from OCTV. Presented options for space available, which requires capital improvements, and option for space available for immediate occupancy. Vettraino suggested, should OACCC be interested that a committee be designated to review, information gather, and understand variables in terms of space, cost, interest, and feasibility. Village is currently trying to locate blueprints to provide total square footage of Burdick building. Station Manager expressed preference to building facility at Seymour Park, due to exposure, use, number of events, parking, and investment return.

Chair Bossardet expressed need for employees to submit written preferences. Chair Bossardet sought legal opinion and confirmed Chair Bossardet, Commissioner Dunn, and Commissioner Hunwick be recused from discussion and vote on station relocation matters.

Commissioner Fisher reminded board of appointment of Commissioners Sutherby and Dunn on relocation research and volunteered to join. Also suggested a pro and con list of each facility.

Bossardet moved to restructure Facilities Committee to Commissioners Fisher and Sutherby and Station Manager to gather all costs, square footage and all other things and report to board in one month (August)/Supported by Dunn
